



## FOSTER AGREEMENT

As a Foster Family, I/We agree to the following:

1. To keep animal(s) in quarantine for **MINIMUM OF FOURTEEN DAYS**.
2. Upon receiving the cat or kitten (s) being fostered, these cats or kittens are agreed to be a part of Pumpkin's Rescue Club and do not belong to the foster. Rescue will make all decisions regarding medical care and will screen all potential adopters. Pumpkin's Rescue Club will make the final decision as to where the cat or kitten(s) will be placed permanently.
3. Cats and kittens will be kept in a safe, indoor, clean environment with access to food/water 24/7.
4. Fosters must get prior authorization for any additional cat or kitten they acquire to be backed by Pumpkin's Rescue Club.
5. If foster cannot continue fostering, please let Pumpkin's Rescue Club know with at least one week's notice.
6. To allow a representative of Pumpkin's Rescue Club to visit my premises to ensure the terms of this agreement has been kept.
7. Pumpkin's Rescue Club is responsible for providing all medications and veterinary care.
8. Foster will have kittens until adopted unless otherwise agreed to by foster and Pumpkin's Rescue Club.
9. Foster Family understands that Pumpkin's Rescue Club retains legal control of the animal(s) and is not authorized to make any legal or medical decisions on his/her behalf. Foster cats or kittens may not EVER be given to a third party without the express consent of Pumpkin's Rescue Club.
10. All medical expenses that are approved by the Pumpkin's Rescue Club and treated through Pumpkin's Rescue Club approved veterinary office will be covered by Pumpkin's Rescue Club. If you take our animal(s) to your vet, it will not be covered unless this is authorized ahead of time.
11. If you choose to adopt your foster animal and this is approved by Pumpkin's Rescue Club, you will be required to pay a reduced adoption fee, only cost of spay/neuter, microchip, test for FIV/FELV and vaccines, typically \$80.

I/we agree to abide by the foster conditions, and I/we have read and fully understand that Pumpkin's Rescue Club may repossess this/these animal(s) at any time if the foster conditions are violated or the animal(s) is mistreated.
